



**Ordinance No. 2020-01**

**AN ORDINANCE CHANGING THE SALARIES FOR PUBLIC OFFICIALS**

**WHEREAS**, increasing the compensation for future elected officials is in the best interests of the Town of Magnolia Springs; and,

**WHEREAS**, one councilmember chairs the Public Works and Safety Committee and must expend effort and time to chair that committee in addition to that councilmember's existing obligations to the Town Council; and,


**WHEREAS**, the Town Council has determined that increasing the compensation to future members of the Town Council and the Mayor is in the public interest and that the additional demands placed on the councilmember who chairs the Public Works and Safety Committee requires additional compensation.

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED** by the Town Council of the Town of Magnolia Springs, Alabama, while in regular session on the 11th day of February 2020, as follows:


- Section 1.** The salary of the Mayor of the Town of Magnolia Springs, Alabama, shall be and the same is hereby fixed at the sum of **\$500.00** per month and will be paid at the regular council meeting.
- Section 2.** That each Councilmember shall be compensated at the sum of **\$100.00** per month and will be paid at the regular council meeting.
- Section 3.** The Councilmember who chairs the Public Works and Safety Committee shall be compensated an additional **\$250.00** per month and will be paid at the regular council meeting.
- Section 4.** There will be no compensation for the Mayor or Councilmembers for attending special meetings; and,
- Section 5.** Ordinance 2012-01 adopted by the governing body of the Town of Magnolia Springs, Alabama on January 24, 2012 shall be and hereby is repeal, such repeal to become effective on the effective date of this Ordinance.


**BE IT FURTHER ORDAINED** that this Ordinance shall become effective on the first Monday in November 2020 and shall continue in force and effect until repealed by action of the Town Council.

**ADOPTED AND APPROVED on this the 11th day of February 2020.**


