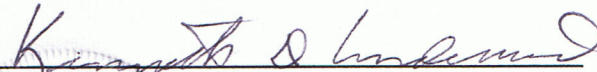
Amending 2012/2013 General Fund Budget

WHEREAS, the Town Council is amending the 2012/2013 General Fund Budget due to the reallocation of funds for committee budgets.

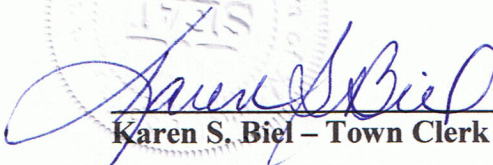
