1. Call to Order:

- Resolution No. 2022-23 Naming Member of the Historic Preservation Commission Mayor Kim Koniar stated that David Houser will be appointed. Councilmember Bob Turner made motion to approve Resolution No. 2022-23. Second, by Councilmember Ross Houser. All in favor. Motion carried.
- Resolution No. 2022-24 Adopting Transportation Plan Pursuant to the Rebuild Alabama Act Town Clerk Hannah Driskell noted that this is an annual resolution that has to be passed before the end of August. Councilmember Steve Mobley discussed the condition of the streets in certain places in Town that the funds could be allocated to repair those streets.
