**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO
AN AGREEMENT WITH ASPHALT SERVICES, INC. FOR
RESURFACING MCCOY LANE AND PATCHING SECTION OF

WHEREAS, the Town of Magnolia Springs wishes to resurface McCoy Lane and patch section of Village Green Drive, Magnolia Springs, Alabama.

THEREFORE, BE IT RESOLVED by the Town Council of the Town of Magnolia Springs, Alabama, while in regular session, that the Town Council authorizes Mayor Kim Koniar to execute an agreement with Asphalt Services, Inc. for the resurfacing of McCoy Lane and patching on section of Village Green Drive, Magnolia Springs, Alabama not to exceed **twenty-five thousand, two hundred and eighty-four dollars and twenty-five cents (\$25,234.25)**. The Mayor is hereby authorized to disperse the funds in one (1) lump sum payment at completion of project.

ADOPTED AND APPROVED on this 20th day of December 2022.

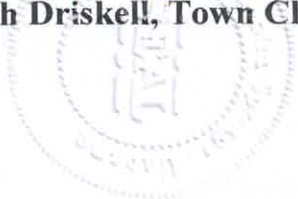
